Requirements for Use

Retail location over-treating seed corn is a slowly growing trend, and can provide important benefits to a corn crop, but the practice is not universally endorsed and is sometimes strongly discouraged by seed companies.

It is crucial to protect the integrity of the seed for proper germination, stand establishment and seedling vigor.

These Requirements for Use are to provide guidance to Nutrien Ag Solutions retail locations for its safe use.

Crop Safety	Nutrien Ag Solutions must control crop safety liability by following these minimum practices:
Sample Retains	Always keep a retain sample of each batch of seed treated. To order sample bags, go to www.nutrienprint.com and order item # LPI8246
Planting Window	Plant within 120 days of application.
Nutrien Ag Solutions ONLY	Loveland and Nutrien Ag Solutions will not support the use of Awaken CoFlow on corn seed outside of authorized Nutrien Ag Solutions retail locations.
Authorized Equipment & Proper Handling	<p>All crop seed is susceptible to damage from excess handling. Equipment must be designed to safely handle seed corn to minimize potential mechanical damage to seed germination and maintain seed integrity.</p> <ul style="list-style-type: none"> • Use only authorized treatment equipment with adequately safe seed handling. • Use a seed ladder for load-out into a seed box or seed tender to avoid seed damage from a vertical drop. • If treated seed is being transferred to a closed container such as a seed box, leave top uncovered or open for 24 hours after treatment. • Contact the Nutrien Ag Solutions or Loveland Seed Treatment Managers with questions or for recommendations.
Use of talc or graphite in the planter	Awaken CoFlow is NOT intended to substitute for planter manufacturer recommended lubricants such as talc or graphite. Planter manufacturer recommendations for seed box lubricants should be followed.
Seed Returns and Waiver of Liability	<ul style="list-style-type: none"> • Nutrien Ag Solutions will NOT accept Awaken CoFlow-treated seed returned from the grower. • If a Nutrien Ag Solutions retail location does not have enough experience with Awaken CoFlow on corn to locally warranty its use, a Grower Waiver of Liability should be obtained.
